Workplace Giving is an easy way to make a big difference through your wage.

Simply decide on the amount to donate each pay and your employer will deduct this from your pre-tax salary and forward directly to UnitingWorld. The process is automatic and paperless. There's no need to collect receipts as your total donation is recorded on your annual PAYG payment summary issued by your employer.*

To set up your ongoing donation, complete the form on the reverse and send it to your payroll department. If you invite your employer to match your contribution, your donation can have even more impact in supporting those people and communities who need it most.
