In 2014/15, we appointed a new National Committee for Church Connections complementing the skills of our established committee members and providing us with additional expertise in law, financial management, communications and administration. I warmly welcome our new members and graciously thank those who retired during the 2014/15 financial year for their loyal and diligent service. The Church Connections Unit continued to strengthen over the 2014/15 year. We welcomed Dr Sureka Goringe as Associate Director in November 2014 and together worked with our overseas church partners to reinforce our commitment to the global church and ensure our programs remained robust, effective and highly transparent. These programs act out our shared, lifechanging mission. We're supporting our church partners as they place women into positions of leadership, harness the potential of youth in Zimbabwe and provide ministry and care to thousands of newly baptised Christians throughout China and remote North India.

We're supporting the ministry of those who care for some of the most vulnerable, and together, we're nurturing the life and spirit of our growing global church.

I'm immensely proud of the work of UnitingWorld Church Connections, and once again, I'd like to extend my heartfelt thanks to the dedicated staff, past and present members of our National Committee – and as always, the faithful work of our overseas church partners. 2014/15 SNAPSHOT EQUIPPING CHRISTIAN LEADERS

Our Equipping Christian Leaders program spans the Pacific, Africa and Asia and strengthens our church partners' capacity to address the issues facing their communities.

Leadership in a Changing Climate

This is a new project, supporting our Pacific partner communities to address the impacts of climate change. We help church leaders develop and teach hopeful theologies of creation and stewardship, and provide training in pastoral support, trauma counselling and disaster preparedness. The program enables the church to be an agent of change, inspiring faithful action and preparing vulnerable communities for adaptation and re-location. In 2014/15 year, we launched the project by re-establishing the Tuvalu Climate Desk in the Congregational Christian Church of Tuvalu and funding a Tuvalu-based climate change officer. We also developed a collaboration with the Pacific Conference of Churches, bringing together a regional team to conduct workshops around the Pacific on climate adaption and disaster preparedness.

Pacific Women's Leadership

Over the period, we continued to support 14 women to study in theological college across five Pacific nations, paving the way for these women to become powerful leaders in their churches and communities.

Christian Leaders in Asia

Christianity in Asia is growing at an extraordinary rate. Our program supports our church partners as they face both the challenges and incredible potential of their growing ministries.

These programs are flexible; adapting to the needs of the partner church and sharing the skills and resources unique to each partner community.

In the Eastern Himalayas in India, our partners are developing programs to equip leaders ministering in a Tibetan-Buddhist majority culture. The program includes training in theology, counselling, information technology, government policy and management. We ran a South Asian partners conference (India and Sri Lanka), fostering regional co-operation and doing management training.

In Indonesia, we support the Artha Wacana Christian University in Kupang to provide scholarships to students from poor backgrounds and help raise their teaching standards through facilitating visits from volunteer academics. In Timor Leste, we support our partner church in the training of their Sunday school program, filling a gap where an entire generation of teachers were lost following independence.

In China, we assist the China Christian Council to train theological teachers and leaders, who in turn support more than 70,000 newly established churches and hundreds of thousands of newly baptised people. Our partnership focuses on teaching theology, joint conferences, scholarships for post-graduate studies in Australia and the training and support of aged care personnel.



Young Christian Leaders in Zimbabwe

In rural Zimbabwe we support the Methodist Church in Zimbabwe to protect and train at-risk youth through five day workshops on leadership-training, Bible study, decision making, counselling, entrepreneurship, peace and conflict resolution and HIV and AIDS awareness.

In March and June 2015, our partner conducted a series of workshops, reaching more than 180 young people, nine of whom have disabilities and 21 of whom were from minority groups.

Ministry in the Margins

In a remote community in the Eastern Himalayas, 63 children attended school, many for the first time, as we helped the Church of North India complete the building and opening of a new school. The school employs seven local teachers and three support staff.

"As a physically challenged youth of Zimbabwe, I benefited though this workshop. I am very thankful to you our good friends in Australia. Through this workshop I have seen many doors opening for me because I am now able to think on my own. I am now capable of thinking outside the box and can face any challenge without fear. This workshop has boosted my confidence to the extent that as a physically challenged young woman, I can start my own project or business at any time."

In Fiji, over 100 children from a squatter settlement received basic school supplies through the Methodist Church in Fiji to assist them to attend school. We also supported two students from this community to go to university.

Growing Global Relationships


UnitingWorld Church Connections has a unique approach to global partnership. We offer members of the Uniting Church the chance to meet, share skills and spend valuable time with our overseas partner communities.

In 2014/15 we facilitated nine InSolidarity Exposure trips, enabling 58 members of Australian churches to connect with six different overseas partner churches. These groups visited congregations, schools, community projects, youth and adult groups. There was



- much learning about each other, faith sharing and forming of long-term friendships.
- We filled 37 overseas volunteer placements with 13 different partner churches.
- Over 2014/15, the Church Connections Unit hosted nine leaders from our overseas church partners to attend Australian conferences, facilitated nine members from our Australian church community to visit significant gatherings overseas, and spoke at 14 national
- and international church conferences.




